NATIONAL ASSEMBLY OF PAKISTAN

Islamabad, the 31st January, 1973

The following Act of the National Assembly received the assent of the President on the 30th January, 1973, and is hereby published for general information :—

ACT No. II OF 1973

An Act to amend the Copyright Ordinance, 1962

WHEREAS it is expedient to amend the Copyright Ordinance, 1962 (XXXIV of 1962), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Copyright (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 10, Ordinance XXXIV of 1962.—In the Copyright Ordinance, 1962 (XXXIV of 1962), hereinafter referred to as the said Ordinance, in section 10, after sub-section (2), the following new sub-section shall be inserted, namely :—

“(2A) Copyright shall not subsist in any work referred to in sub-section (2) as respects its reprint, translation, adaptation or publication, by or

under the authority of the Federal Government as text-book for the purposes of teaching, study or research in educational institutions."

3. **Amendment of section 30, Ordinance XXXIV of 1962.**—In the said Ordinance, in section 30, after the words "declared that", the commas, words, brackets, figures and letter ", subject to the provisions of sub-section (2A) of section 10," shall be inserted.

4. **Amendment of section 53, Ordinance XXXIV of 1962.**—In the said Ordinance, in section 53, in sub-section (2), after the word "Pakistan" at the end, the following shall be added, namely :—

"except as respects its reprint, translation, adaptation or publication, by or under the authority of the Federal Government, as text-book for the purposes of teaching, study or research in educational institutions."

5. **General amendment, Ordinance XXXIV of 1962.**—In the said Ordinance, for the words "Central Government" wherever occurring the words "Federal Government" shall be substituted.

6. **Repeal.**—The Copyright (Amendment) Ordinance, 1972 (LVI of 1972), is hereby repealed.

THE FRONTIER CRIMES REGULATION (REPEAL) REGULATION, 1973

REGULATION NO. I OF 1973

REGULATION

to repeal the Frontier Crimes Regulation, 1901 in its application to certain Provincially Administered Tribal Areas

WHEREAS it is expedient to repeal the Frontier Crimes Regulation, 1901 (Regulation III of 1901) in its application to certain Provincially Administered Tribal Areas ;

NOW, THEREFORE, in exercise of the powers conferred by clause (4) of Article 261 of the Interim Constitution of the Islamic Republic of Pakistan, the President is pleased to make the following Regulation :—

1. **Short title and commencement.**—(1) This Regulation may be called the Frontier Crimes Regulation (Repeal) Regulation, 1973.

(2) It shall come into force on such date as the Federal Government may, by notification in the official Gazette appoint in this behalf.

2. **Repeal.**—The Frontier Crimes Regulation, 1901 (Regulation III of 1901) in relation to its application to the Provincially Administered Tribal Areas of Chitral, Dir, Kalam, Swat and Malakand Protected Area, is hereby repealed.

3. **Transfer of Pending cases.**—All criminal cases which were pending under the Frontier Crimes Regulation, 1901 (Regulation III of 1901), immediately before the commencement of this Regulation in the Areas specified in section 2 shall, on such commencement, stand transferred to the court of competent jurisdiction to be tried and disposed of by such court in accordance with the Code of Criminal Procedure, 1898 (Act V of 1898).
